

Board Report

2023 - Retrospective

The highlight of 2023 was the opening of the inpatient department at Hospital San Miguel – Quina Care. With this addition, the hospital is another step closer to becoming a fully comprehensive hospital. Furthermore, outpatient and emergency care continued unabated. It was another remarkable year to look back on.

Hospital

On July 1, 2023, the inpatient departments were opened. There are separate wards for men, women, and children. Additionally, there is an isolation room, a single room for terminally ill patients, and a nursing station. The ability to admit patients has proven to be immensely valuable. Several patients, both adults and children, left the hospital much healthier than when they were admitted. This would not have been possible, or would have been much more difficult, if care had been limited to outpatient services only. Several family members decided to stay in the hostel specially designed for this purpose within the hospital, allowing them to be close to their relative. This is especially beneficial for those coming from far away.

Meanwhile, outpatient care continued as well. The hospital was busy with patients, conducting various laboratory tests and prescribing medications. The emergency department also saw extensive use and was appreciated for the care it provided.

To use the electronic patient record for admitted system patients, various modifications and expansions This were necessary. timeconsuming task was superbly executed by Darius Blaszyk. Thanks to the donation of ten new Acer Chromebooks, all staff members can now use the electronic patient record system on these devices. This also allows them to look up protocols from any location, for example.



Regarding the renovation of the hospital, progress has been made. Of course, the completion of the inpatient departments was significant. Additionally, the renovation of the operating and delivery rooms has begun. Donations from eight sponsors, including the Hendrik van Dijk Fund, the Silver Rosary Foundation, the Casterenshoeve Foundation, the Hofstee Foundation, the C&W DE BOER Foundation, and the Chestnut Foundation, have made this possible.

A sixth house for local staff or volunteers at the hospital has been completed. This was necessary to provide housing for everyone who needs it.

Paid staff and volunteers in Ecuador and the Netherlands

With the opening of the inpatient departments, hiring more paid staff was necessary. Therefore, three nurses and a second cleaner were hired in 2023. Additionally, the receptionist, the first cleaner, two nursing assistants, a lab technician, and a doctor remained employed. With the two Dutch tropical doctors, the staff now comprises twelve paid employees. These employees are employed by Quina Care Ecuador. Quina Care itself has no paid employees.



Quina Care has an extensive volunteer base:

- Fourteen medically trained volunteers such as doctors, a medical analyst, and a virologist/lab technician who have worked in the hospital one or more times. In some cases, their accompanying partners also contributed with non-medical tasks.
- Four permanent medical specialists and a dietitian who can be consulted in the Netherlands for questions.
- Three volunteers for digital matters such as the electronic patient record system and the hospital's IT and security.
- Two translators for English and Spanish translations.
- A fundraising volunteer, an administrative support volunteer, an ambassador, and two members of the audit committee.

For volunteers who have direct contact with patients, access to the electronic patient record system, or represent Quina Care externally, a volunteer agreement is concluded. They are also asked to sign the code of conduct.





The atmosphere among the local and volunteer staff in the hospital is very good. Staff members regularly express their gratitude for being part of Quina Care and for having the security to provide for their families through their steady jobs. The joint lunch with a work meeting has remained a regular monthly event, demonstrating how engaged everyone is. Staff members often come up with valuable ideas to further improve care. The weekly sports activity has also become a routine part of their schedule.



Thanks to donations from the GNAP foundation, an organization dedicated to promoting education in developing countries, several staff members have started or will start additional training. This ensures that the staff can continue to develop professionally.



Baukje Zaaijer, who has raised funds for Quina Care multiple times and visited the hospital several times, has become the ambassador for Quina Care. She succeeds Floris van der Sman in this role. Baukje will work on increasing the awareness of Quina Care and organizing fundraising activities as an ambassador.

Collaborations

The long-standing collaborations with Fundación Lunita Lunera and La Federación de Mujeres continued in 2023. Insulin for Life regularly donated insulin again.







As part of Jacob van der Ende's doctoral research, which he conducts in his own time, in collaboration with the University of Amsterdam/Amsterdam UMC and the University of Quito, the prevalence of tropical diseases in the area where the hospital is located is being mapped. This includes field research in which several villages are visited to test residents for malaria. If someone tests positive, treatment is started immediately. This way, the residents directly benefit from this collaboration.





A collaboration has been established with the Amsterdam University of Applied Sciences, dietetics program, through volunteer Lisette van Miert, a dietitian. In 2023, a group of students completed an initial assignment. This resulted in a report on anemia and malnutrition in children, along with recommendations for a menu for children admitted to the hospital.

There is good contact with the Ecuadorian Ministry of Health. If necessary, patients can be transferred to the hospital in Lago Agrio by their ambulance. Additionally, the "health table" is attended monthly. This is a meeting where all authorities in Puerto el Carmen involved in healthcare, including the Ministry of Health, the mayor, and the fire department, participate. During these meetings, the health problems in the region and possible solutions are discussed. Furthermore, the hospital is part of the crisis management team. This team meets in the event of a disease outbreak, natural disaster, or other situations that threaten the safety and/or health of the community.





Quality Mark

In 2023, Quina Care continued to hold the CBF quality mark. CBF stands for Central Bureau on Fundraising. With this quality mark, an organization is recognized as one of the approved charities, indicating compliance with strict quality requirements. This ensures donors that their contributions are spent appropriately and



contribute to a better world. The CBF continues to monitor whether the organization still meets the quality standards after the quality mark is awarded.

Sustainability

Quina Care pays attention to sustainability. The hospital operates entirely paperless by using the electronic patient record system. Materials are used as efficiently as possible. Medical instruments are sterilized in reusable cloths.

Local Authorities and Population

The contacts with local authorities are good. This was evidenced by the appreciation received by Hospital San Miguel – Quina Care from the mayor of Puerto el Carmen on April 30, 2023. On this day, the canton of Putumayo celebrated its 54th anniversary. The appreciation was a thank you on behalf of the canton for the work the hospital does for vulnerable people in the region and for improving the health of the residents.





The local population also regularly expresses their gratitude for the presence of the hospital.

Finances

Adore Ecuador Travel continues to donate a portion of their proceeds to Quina Care in Ecuador.





Various projects have been funded by endowment funds and foundations, such as Stichting Benevolenta, W.M. de Hoop Stichting, Stichting Do&Well, Stichting Filadelfia, Stichting Noord Wolfsbergen, PJ Rogaar Stichting, and the diaconate of the Protestant Church of Scheveningen. Some foundations have supported Quina Care for an extended period, including Schumacher-Kramer Stichting, AKBHHH, C&W DE BOER STICHTING, Stichting Salem Ermelo, and Stichting Kringloopwinkel De Wisselbeker.

Many private donations have also been received, some one-time and some periodic. Several people have renewed their leaf on the Quina Yura donation tree.

Esther Lems and Ivar Stokvis will both work as volunteers in the hospital for six months starting in February 2024. Esther will work as a doctor, and Ivar will explore ways to improve and make the hospital's water system more sustainable and the possibility of installing solar panels. They decided to participate in the Linschoterloop on December 23, 2023, to raise money for Quina Care. Along with several friends and family members, they ran the half marathon. Yvonne van der Ende and Darius Blaszyk decided to participate by walking a half marathon. In total, over €10,000 was raised, enough to pay a nurse's salary for more than nine months.





In 2023, it remained possible to contribute to Quina Care through SponsorKliks and 123inkt.nl. Additionally, Quina Care joined Statiegeld Nederland to receive extra funding through this channel as well.

With the opening of the inpatient department, operating costs have significantly increased. Much effort has been put into creating a plan of action to manage these costs.

The audit committee, appointed in 2022, has reviewed the 2022 annual report.



Official Documents

Quina Care has continued to use the GDPR file, the integrity policy, and the code of conduct. These documents are shared with every volunteer. Volunteers working at the hospital or those with a specific task in the Netherlands must sign a volunteer agreement. Volunteers working at the hospital must also provide a Certificate of Good Conduct and sign a confidentiality agreement.

Promotion

In 2023, a digital flyer was created to share with interested parties, including potential sponsors and donors. The flyer is available in Dutch, English, and Spanish.



Complaints

The Quina Care website explains how people experiencing issues with Quina Care or having other complaints can report them. No complaints were received in 2023.

For volunteers who experience problems with Quina Care, an external confidential advisor, Dirk Houtman, has been appointed.

Quina Care Netherlands

The composition of the board has remained unchanged, consisting of three members. Duties of the Dutch board include recruiting new sponsors, donors, and volunteers, maintaining relationships with existing sponsors, donors, and volunteers, handling administration and financial planning. Additionally, the board is responsible for shaping the hospital's policies and vision in consultation with local tropical doctors and the board of Quina Care Ecuador.

Both Cootje Bouwman, chairperson, and Yvonne van der Ende, treasurer, visited the hospital in 2023. They both found the experience very valuable and motivating.



Quina Care Ecuador

The composition of the board of Quina Care Ecuador has also remained unchanged. The board is involved in hiring hospital staff and managing hospital operations. There is regular and open communication between the boards of Quina Care Ecuador and the Netherlands.

Quina Care US


The composition of the board of Quina Care US has changed. Donna Gianoulis has been replaced as treasurer by Josefina Coloma, and Daniela Navia has been replaced by Lourdes Heredia. The board's main task is to recruit sponsors and donors. Several donations have been received from the United States, including funds for the purchase of an X-ray machine.





2024 – Outlook

Following the opening of the nursing departments in 2023, 2024 will focus on further expanding the hospital with a delivery room, an operating theater, and an X-ray machine. Naturally, efforts will also be directed towards maintaining the already existing healthcare services.



The Hospital

In 2023, renovations began on two spaces to create an operating theater and a delivery room. These renovations will be completed in 2024, enabling the hospital to perform surgeries, including cesarean sections.

With the donation received in 2023, an X-ray machine will be purchased in 2024. This machine will be used for imaging limbs, as well as abdominal and lung X-rays, providing a significant enhancement to the hospital's healthcare capabilities. It has been determined that there are inadequate options for purchasing such equipment in Ecuador, so it will be procured from the Netherlands. Quina Care will ship the machine itself in a container to Ecuador, which will also include the last remaining donated items from the Netherlands.

In 2024, efforts will be made, including through volunteer initiatives, to explore improving the hospital's water supply and the possibilities for solar energy. This initiative aims to make the hospital as sustainable as possible.



Security

The hospital continues to utilize its installed security system, with no further adjustments deemed necessary. The recent unrest in Ecuador has not affected the hospital thus far.

Personnel

In January 2024, two new staff members were hired: an additional receptionist and an extra nurse. The receptionist, who has been working at the hospital since its opening and is currently pursuing a master's degree in hospital administration, will take on more responsibilities in hospital administration.



With the opening of the operating and delivery rooms, more personnel will need to be hired. Further expansion of the staff will be determined at a later date.

Volunteers



Several doctors will voluntarily work at the hospital for 6 months in 2024. Additionally, the hospital will be visited briefly by several healthcare providers, including doctors and an anesthesia technician, to assist in setting up, for example, the further operating room or to professionalize existing departments.

In the Netherlands, work will continue with volunteers who have been involved with Quina Care for some time. If necessary, new volunteers will be sought.



Finance

With the opening of additional departments and the hiring of additional staff, operating costs are expected to rise significantly. It is also anticipated that there will be an increased need for the support fund from patients. For admissions, for example, a higher contribution is required compared to outpatient consultations, which may result in more instances where patients cannot afford the costs. In recent years, it has already been shown that finding funds for operating costs is more challenging than for more specific projects or equipment purchases. Therefore, this will remain an important focus for the Quina Care boards. The fundraising volunteer and our ambassador will also make significant contributions here. Ambassador Baukje Zaaijer has secured a commitment that the proceeds from a benefit dinner for medical staff will go to Quina Care.

Various donations from funds, foundations, and private donors have already been committed for 2024, partly through multi-year agreements. In addition, efforts will be made to attract new sponsors and donors. Initial steps have been taken for this in the Netherlands, the United States, and Ecuador. It will still be possible to purchase a leaf for the donation tree Quina Yura. Support for Quina Care will also continue through SponsorKliks, 123inkt.nl, and Statiegeld Nederland.

Promotion

Quina Care will continue to focus on a well-maintained website and regular updates through social media and quarterly newsletters. The digital flyer will also be utilized.

If opportunities arise, board members or the ambassador will give presentations at foundations, endowment funds, or events.

Quina Care Netherlands

In early 2024, Quina Care Netherlands expanded its board to include a fourth member, Merlijn Hutteman. With his arrival, responsibilities will be further divided to reduce the workload on individual board members. If possible, the board will be further expanded with a fifth member.

Quina Care Ecuador

If possible, the board of Quina Care Ecuador will also be expanded, as the responsibilities for this board increase with the growth of the hospital. The board remains heavily involved in hiring local personnel, managing the hospital's operations, and accounting for its revenues and expenses.



Quina Care US

The board of Quina Care US remains unchanged for now. Its primary task continues to be fundraising among donors in the United States. If possible, tropical doctors Jacob van der Ende and/or Carolien van der Ende will visit the United States to give presentations to multiple potential sponsors and donors, aiming to increase awareness of Quina Care.

Notes to the Balance Sheet

Tangible Fixed Assets

Tangible fixed assets obtained through donations are valued at the estimated price that would be paid if the assets were to be purchased. A distinction is made between already used assets and new assets depending on the condition of the donated asset.

Self-purchased assets are valued at the actual purchase price paid.

Tangible fixed assets obtained through donations are processed as such in the statement of income and expenses. All tangible fixed assets are intended for the hospital and have been transported to Ecuador for the most part in recent years. Administratively, tangible fixed assets are recorded as a donation to Quina Care Ecuador. For an overview of the movement of tangible fixed assets, please refer to the inventory and equipment fund flow statement.

Receivables

All receivables are short-term and were received in the first quarter of 2024.

Cash and Cash Equivalents

The cash and cash equivalents are freely available to the foundation.

Reserves

The unappropriated reserve can be used where necessary, such as for projects that have not received sufficient donations, for expenses related to the realization of the hospital where no subproject exists, and for expenses related to fundraising, administration, and management costs. Two appropriated reserves have been formed:

- 1. The board has allocated €125,000 for operating costs of the hospital that are not fully covered by donations.
- 2. The hospital has a lot of medical equipment that is more prone to malfunctions and defects in tropical conditions. The board has allocated €15,000 for emergency repairs and equipment replacement.



Appropriated Funds

The objective of Quina Care is the establishment of the hospital in Puerto el Carmen. Within this objective, multiple projects have been identified for fundraising purposes. Donations specifically received for a project that were not spent in the fiscal year are included in a appropriated fund on the balance sheet.

For a comprehensive overview of all project activities, flow statements are also included for projects entirely within the fiscal year.

Current Liabilities

These are costs from 2023 that were not paid by year-end. Payment of these costs took place in the first quarter of 2024.

Notes to the statement of income and expenses

Receipts: received donations and gifts

Donations and gifts have been received from private individuals, business and non-profit organisations such as equity funds and foundations. Quina Care did not receive any government funds or other revenues that are not specifically mentioned here.

Expenditure: spent on hospital realisation

This includes all expenses incurred to realize the hospital. This includes the costs of renovating the hospital, the donation of inventory and equipment and the operating costs of the hospital. The expenditure of the projects as mentioned in the progress statements is also included.

Expenses: publicity costs, administrative and overhead costs

This includes the costs for the website, the financial administration, insurances and memberships.

Financial income and expenses

This includes the costs of keeping the Triodosbank bank account and the costs of payment transactions via iDeal.
